

VALIDATION RULES

- (A) The validation rules must be read in conjunction with Section D.1. of the Business and Technical Specifications and to distinguish between the BOPCARD and BOPCUS systems, the attributes only related to the **BOPCUS**, **NON RESIDENT RAND**, **NON REPORTABLE**, **INTERBANK** will be reflected in **BLUE** and the attributes only related to **BOPCARD** will be reflected in **RED**. Attributes related to all the reporting functions will be reflected in **BLACK**. **BOPDIR** transactions are the same as for BOPCUS including attributes reflected in **MAROON**. For reference purposes, all the available attributes are reflected with a code, which is listed below, and common errors will be allocated with the same error code and description where possible.

Due to the 2nd phase of the project to implement NON RESIDENT RAND (B) and INTERBANK (D), the aforementioned ReportingQualifiers may be excluded from the validation rules. The NON RESIDENT RAND transactions must be reported under the BOPCUS ReportingQualifier from 2013-08-19 until further notice. Certain validation rules have been incorporated into the BOPCUS ReportingQualifier, which will be amended in future.
