Authorised Dealer in foreign exchange

The attention of Authorised Dealers is drawn to Government Notice No. 1288 published in Government Gazette No.39565 of 2015-12-29 in terms of which Bank of India is appointed as an Authorised Dealer in foreign exchange.

In addition to the necessary amendments to the Orders and Rules under the Exchange Control Regulations, 1961, the name of Bank of India must be added to the list of Authorised Dealers in foreign exchange in Section A.2(A) of the Exchange Control Rulings.

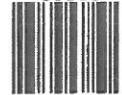
