Exchange Control Circular No. 4/2019

Authorised Dealer in foreign exchange

Authorised Dealers in foreign exchange (Authorised Dealers) and Authorised Dealers in foreign exchange with limited authority (ADLAs) are referred to Exchange Control Circular No. D.181 dated 1998-03-05 and are advised that the appointment of Bank of Baroda has been cancelled with immediate effect. Accordingly, the attention of Authorised Dealers and ADLAs is drawn to Government Notice 116 of 2019 published in Government Gazette No. 42270 of 2019-03-01 in terms of which Bank of Baroda is deleted from the list of Authorised Dealers.

In addition to the necessary amendments to the Orders and Rules under the Exchange Control Regulations, 1961, the name of Bank of Baroda is deleted from the list of Authorised Dealers in sections A.2(A) and A.2(B) of the Currency and Exchanges Manual for Authorised Dealers and the Currency and Exchanges Manual for Authorised Dealers in foreign exchange with limited authority (Manuals) respectively as well as in the guideline documents for business entities and individuals (guideline documents).
