SADC-RTGS: Main indicators

In February 2019

SADC-RTGS processed **26,895** transactions to the value of **ZAR 96.55 Billion**

Average number of transactions processed per day were **1,345** representing the average value of **ZAR 4.83 Billion**

Total number of transactions settled to date is **1,356,025** representing the value of **ZAR 5.52 Trillion**
(USD 395.77 Billion/ EUR 347.57 Billion)*

Peak volume of **32,059** transactions was in **Oct 2018** and peak value of **ZAR 119.53 Billion** was in **Aug 2017**

Total Number of participating countries is **14**

Total Number of participating Banks including central banks is **81**



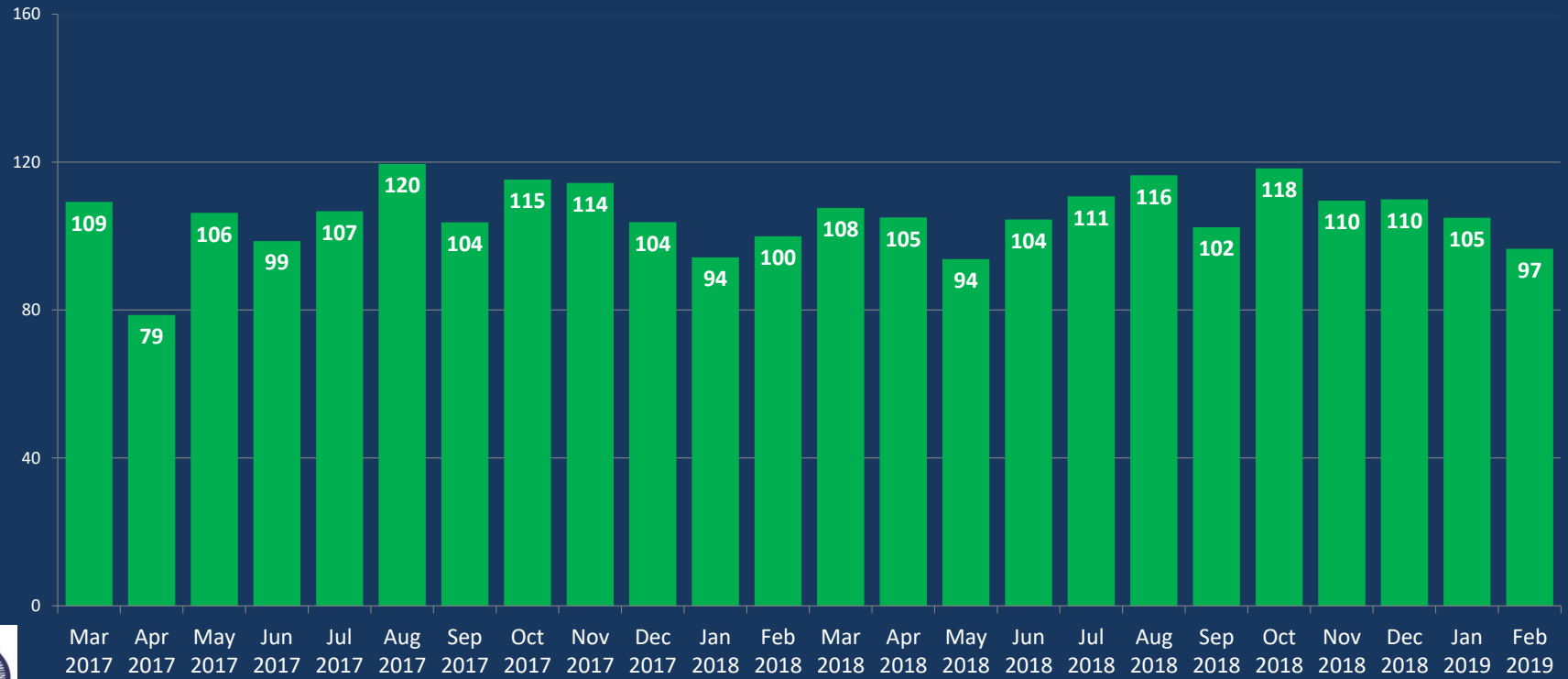

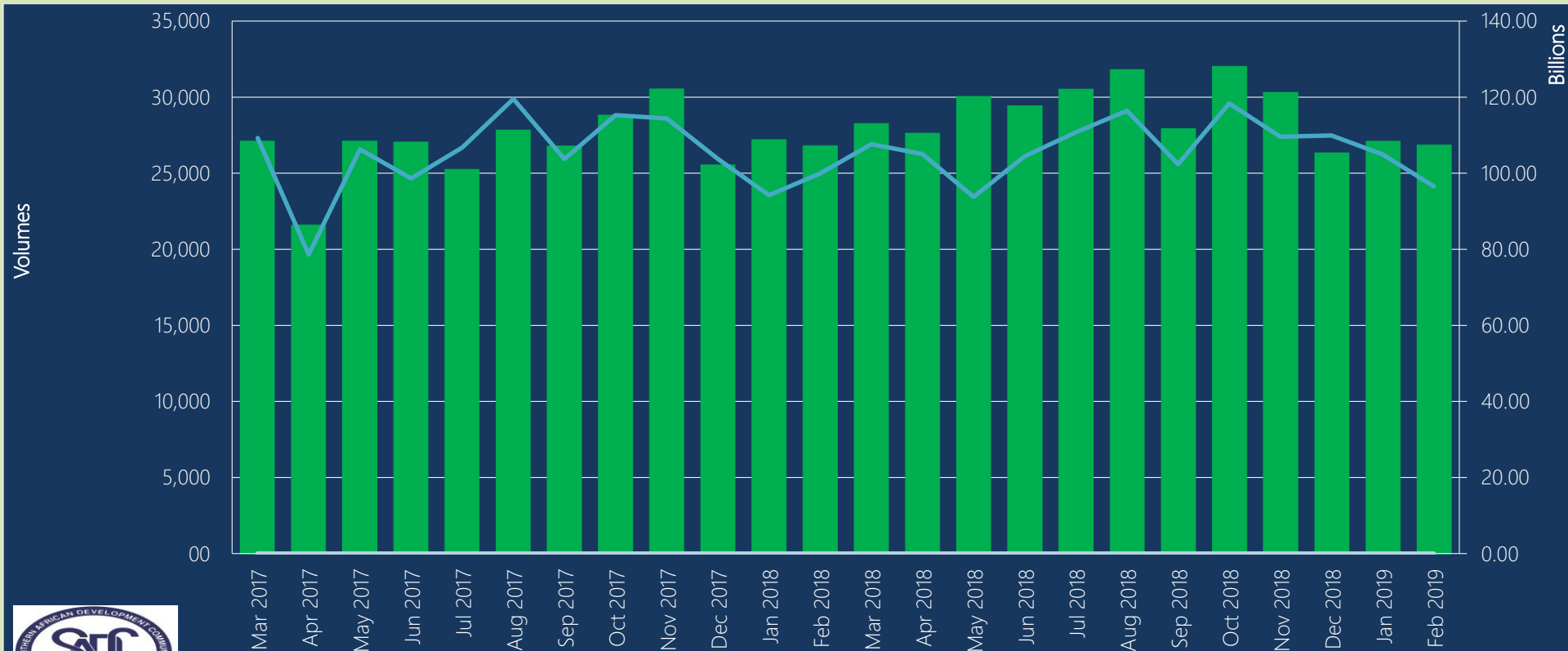


SADC-RTGS: Value of transactions settled
