In January 2020

SADC-RTGS processed 29,890 transactions to the value of ZAR 104.06 Billion

Average number of transactions processed per day were 1,359 representing the average value of ZAR 4.73 Billion

Total number of transactions settled to date is 1,679,720 representing the value of ZAR 6.65 Trillion*

*(USD 448.18 Billion/EUR 406.42 Billion)

Peak monthly volume of 32,976 transactions was in Oct 2019 and peak value of ZAR 119.53 Billion was in Aug 2017

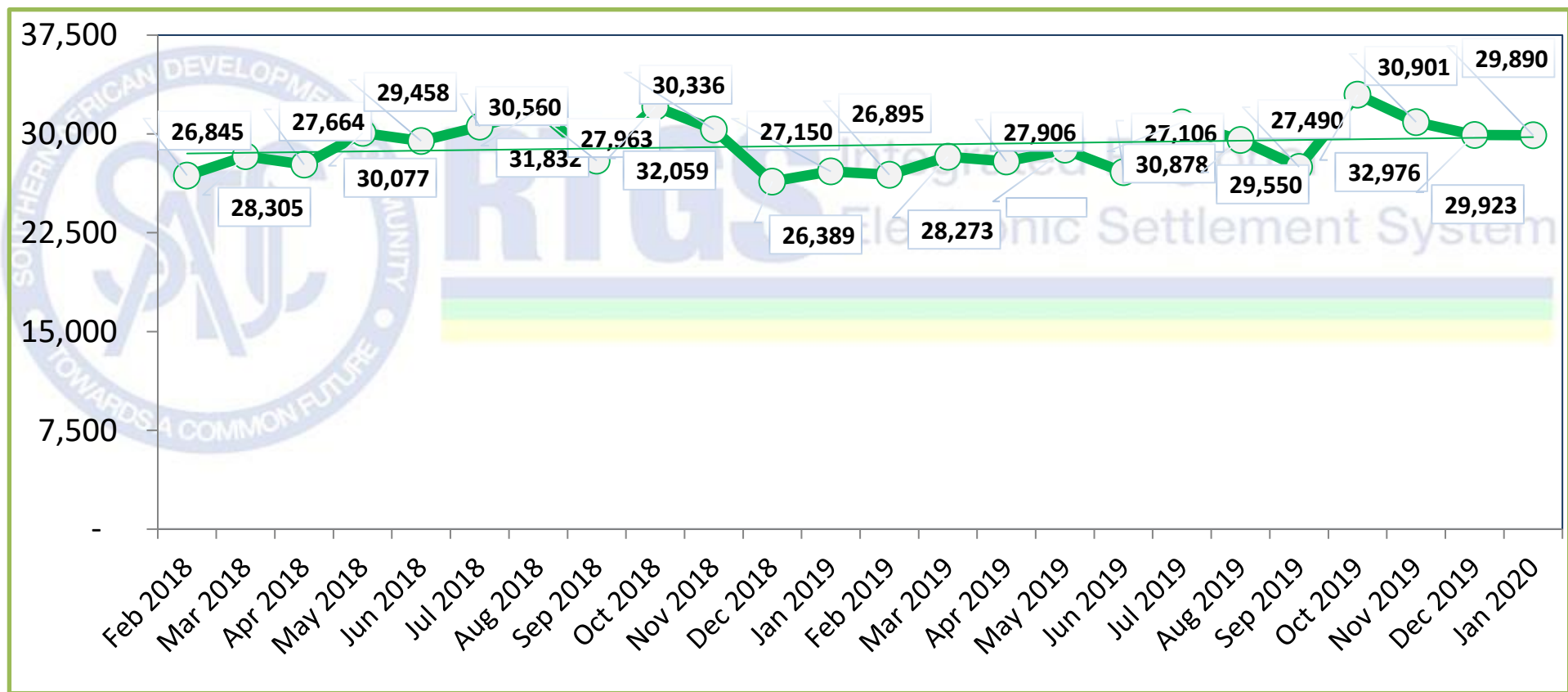

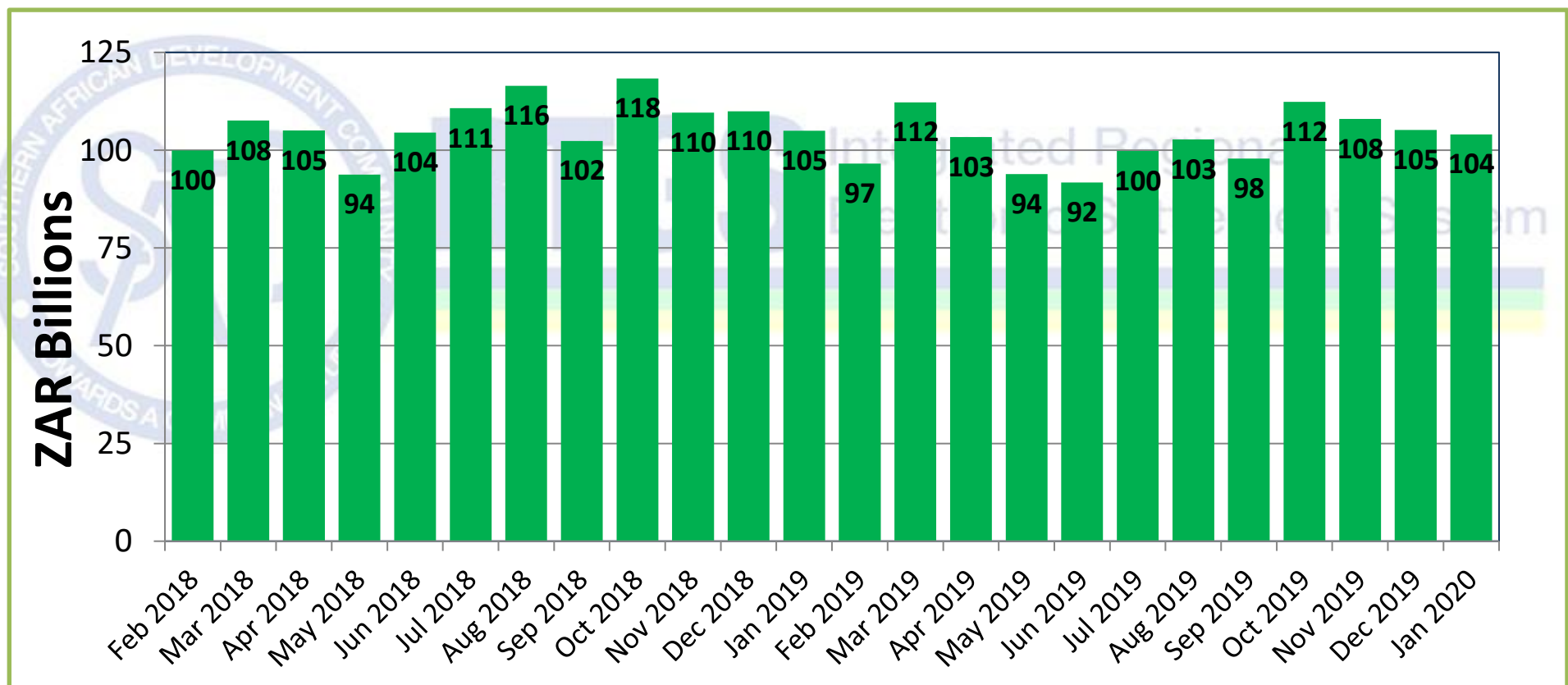

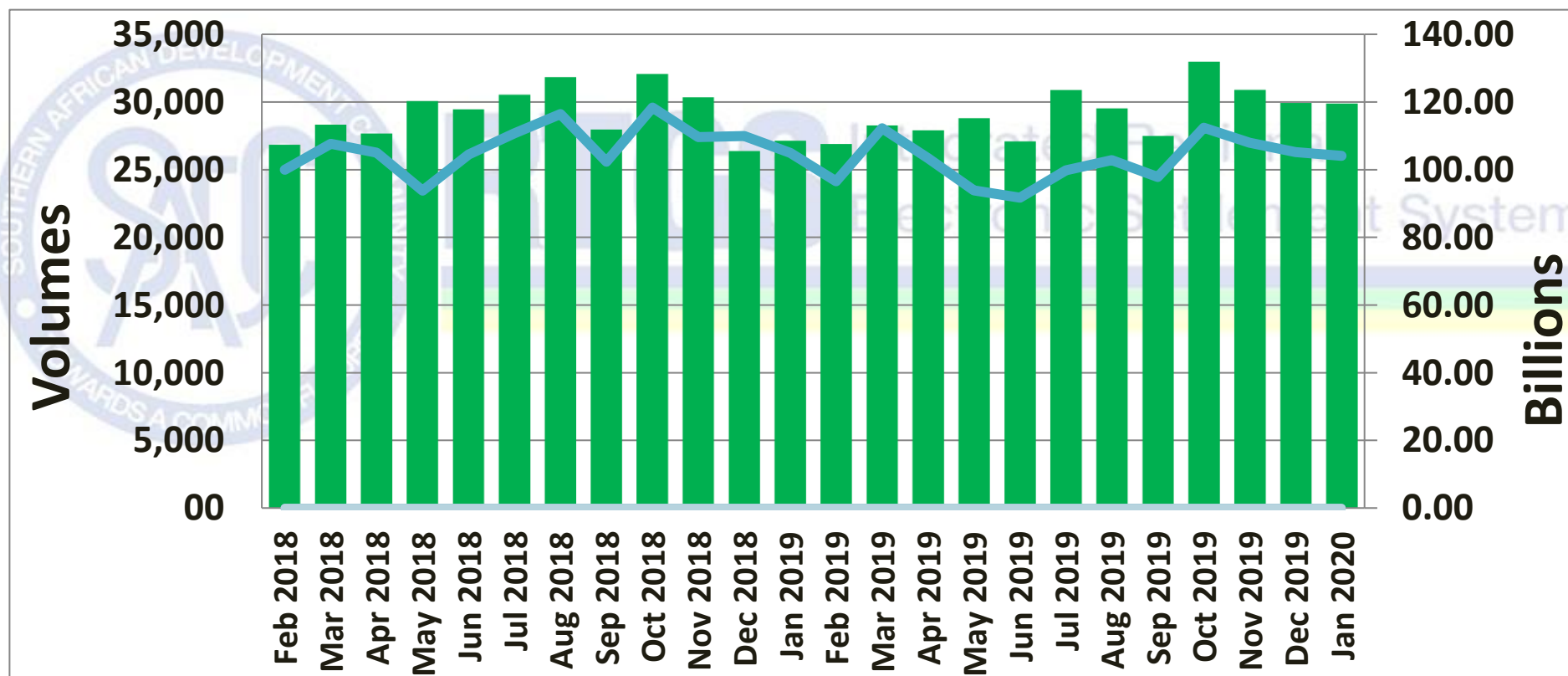
Total number of transactions settled
