Main Indicators

In May 2019

- ◆ SADC-RTGS processed 28,802 transactions to the value of ZAR 93.9 Billion
- ◆ Average number of transactions processed per day were 1,309 representing the average value of ZAR 4.27 Billion
- ◆ Total number of transactions settled to date is 1,441,006 representing the value of ZAR 5.83 Trillion*
***(USD 395.16 Billion/EUR 354.36 Billion)**
- ◆ Peak monthly volume of 32,059 transactions was in Oct 2018 and peak value of ZAR 119.53 Billion was in Aug 2017
- ◆ Total Number of participating countries: 14
- ◆ Total Number of participating Banks (including central banks): 81

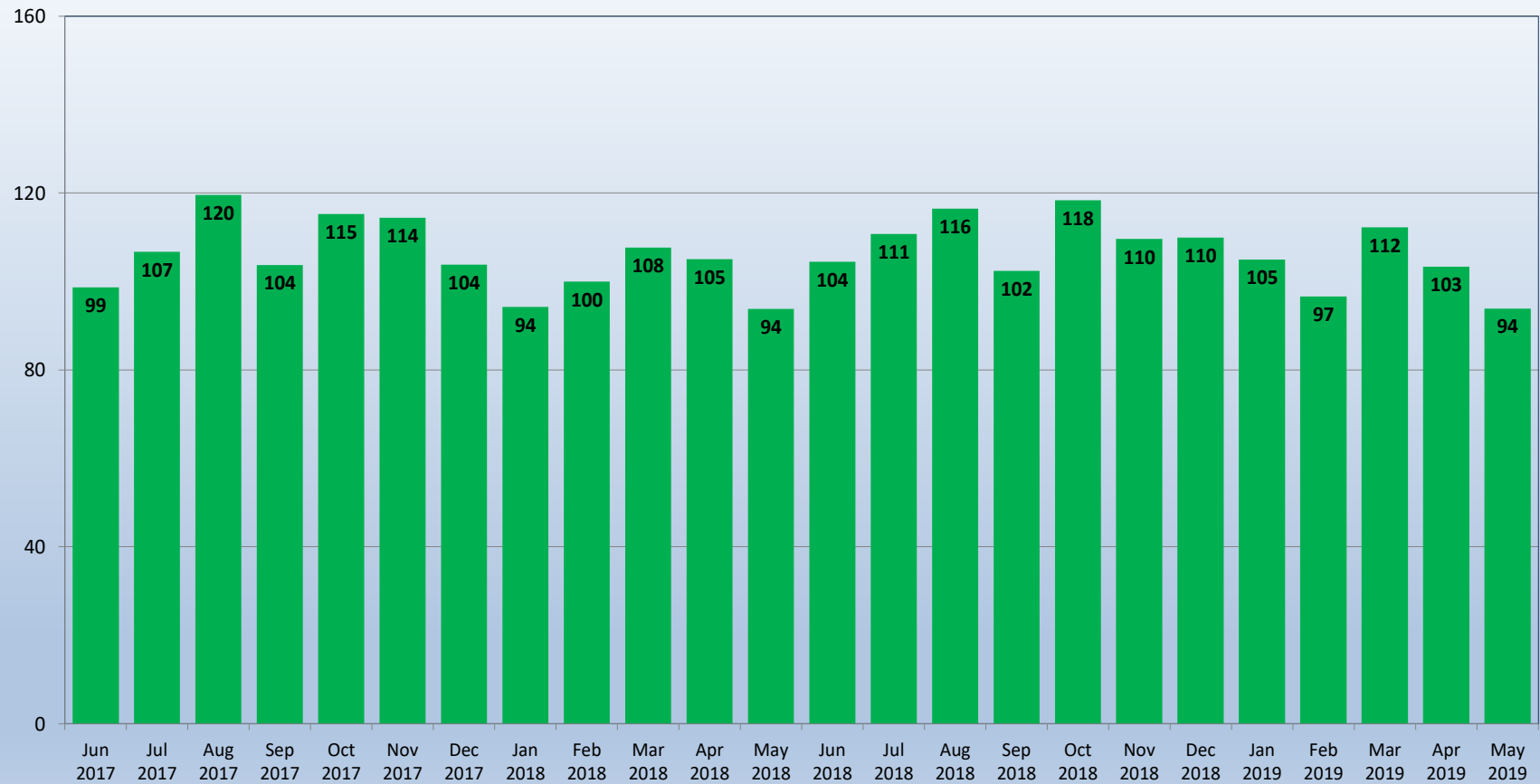


Total number of transactions settled

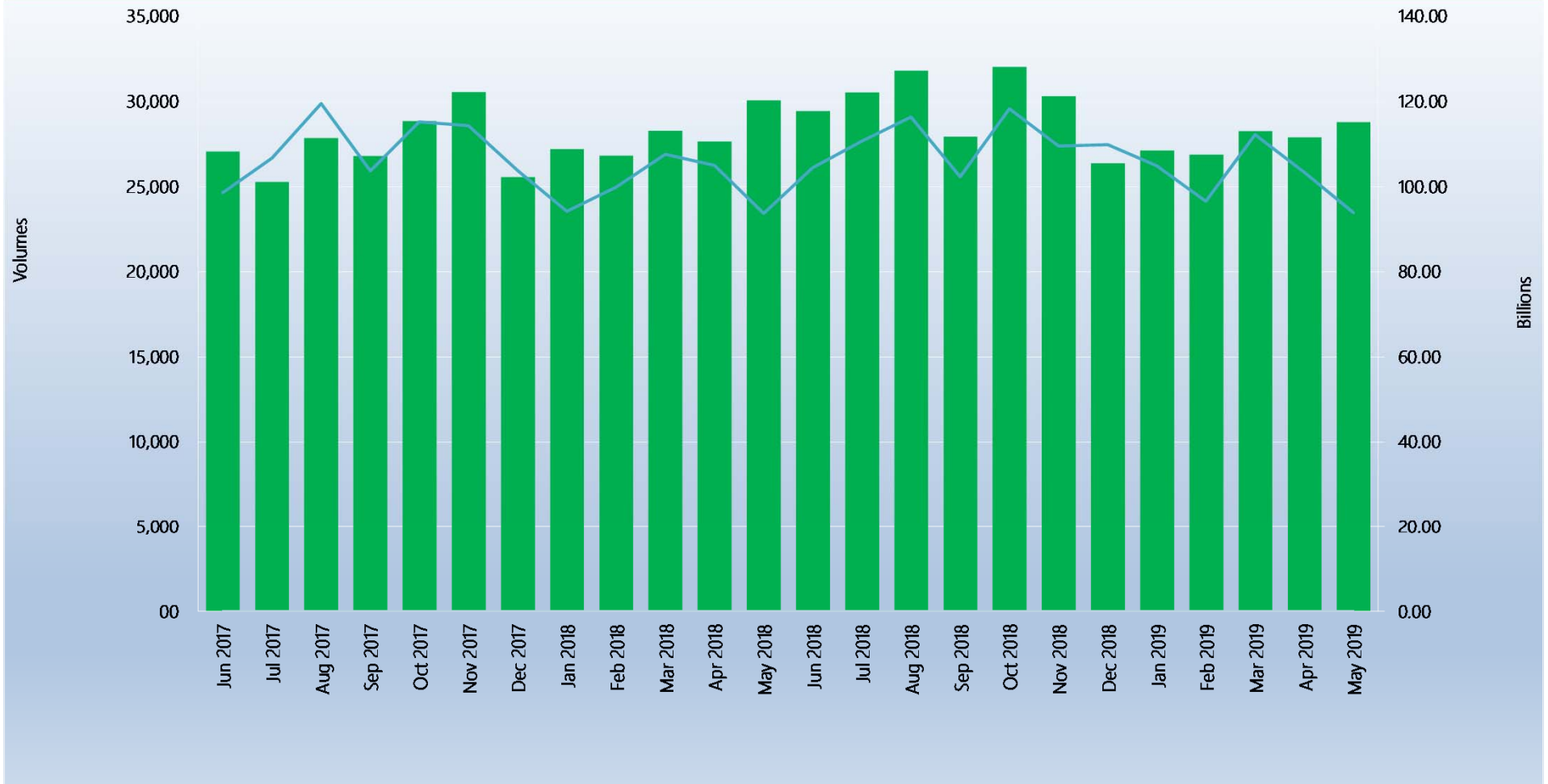


Value of transactions settled
