SADC-RTGS: Main indicators

In November 2018

SADC-RTGS processed **30,336** transactions to the value of **ZAR 109.60 Billion**

Average number of transactions processed per day were **1,379** representing the average value of **ZAR 4.98 Billion**

Total number of transactions settled to date is **1,275,591** representing the value of **ZAR 5.21 Trillion**
(USD 379.95 Billion/ EUR 333.93 Billion)*

Peak volume of **32,059** transactions was in **Oct 2018** and peak value of **ZAR 119.53 Billion**
was in **Aug 2017**

Total Number of participating countries is **14**

Total Number of participating Banks including central banks is **81**



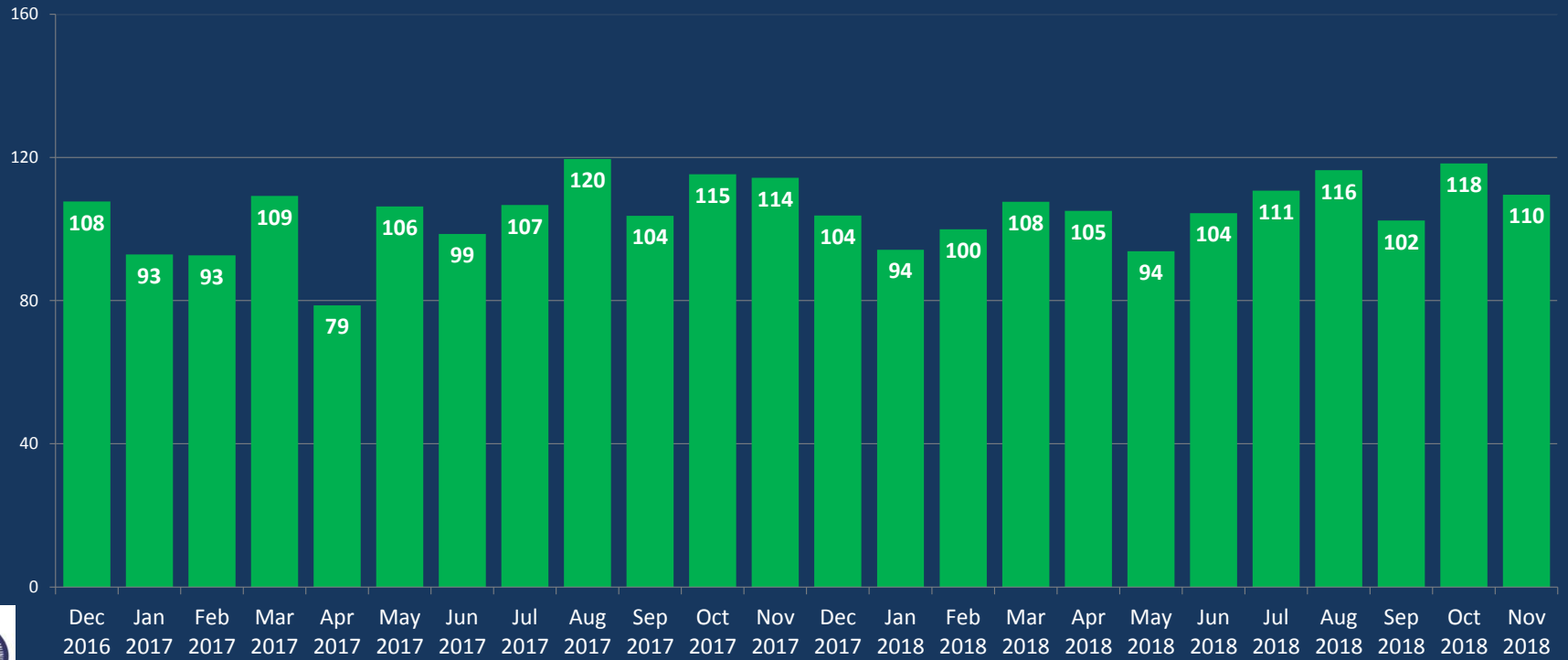

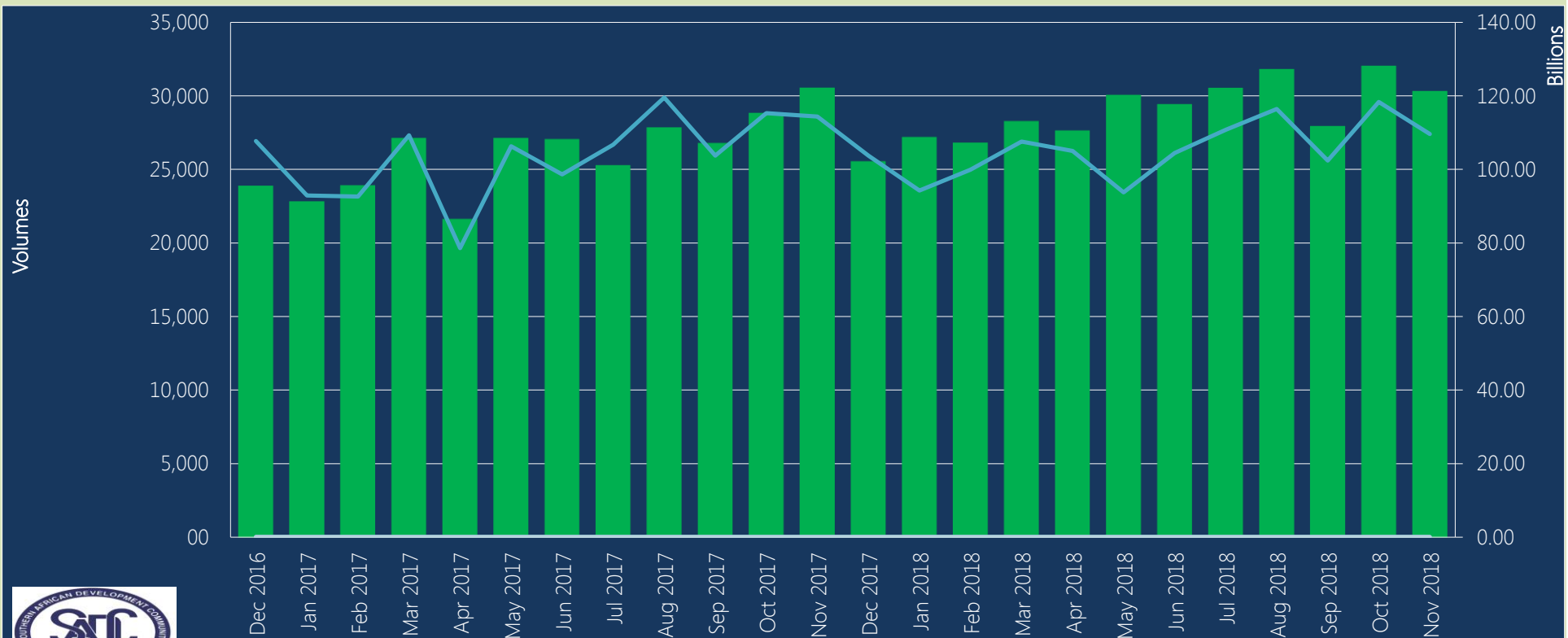


SADC-RTGS: Value of transactions settled
